In accordance with section 7048(i) of the Department of State, Foreign Operations, and Related Programs Appropriations Act, 2019 (Div. F, P.L. 116-6), the Department intends to obligate and expend funds withheld in FY 2019 from organizations indicated in the enclosed chart pursuant to section 7048(a). On October 22, 2019, the Department submitted a report and determination that indicated that all organizations subject to the withholding requirement had met the requirements set forth in section 7048(a), except the International Civil Aviation Organization (ICAO). Therefore, the Department will continue to withhold funds from ICAO.
